Public Library Division Rose Harrison

Youth Services Division, Lea Rosell

The YSD meeting was held on 10/9 at DDL. Topics of discussion relevant to YSD business were the results of the summer reading challenge and how YSD can respond to those changes, Blue Hen Book Award updates, and discussion about what YSD members want from the division.

Though 10 libraries saw increases in summer reading sign up numbers, 19 libraries saw a drop in participation this year. 5 libraries did not report. Much discussion was centered on why this happened and how we can change the summer reading challenge to boost community engagement in future years. It was agreed that interested members of YSD and DDL come together sometime in January 2016 to discuss changes and create a strategic plan for YSD. Our hope is that the strategic plan with distill best practices, be a breeding ground for new ideas, and bring together youth librarians throughout the state as we focus on a common vision moving forward.

A separate committee was assembled to focus on summer reading funding. The committee will reach out to private donors to collect funds that will be used to pay for marketing and publicity on a state wide level. Radio, television, billboards, and print media buys will be the goal of this committee. Work will commence December 1st.

Blue Hen Book award votes are due to the President no later than COB 11/15/15. The votes will determine the winner of the 2016 Blue Hen Book Award. Library staff and other interested parties will be notified of the winner in each category in December. Public recognition of the winners will be made in February to coincide with Love Your Library Month. In March, the President will send out a congratulatory letter and certificate to each of the authors.

YSD has been brainstorming ideas about how to increase membership. In doing so, it has been brought to our attention that most new hires have no idea what DLA is, how it works, or how it benefits them as individuals. It was proposed that Sara Thomas and I put together a welcome packet to be distributed to new hires by each site's director upon commencement of employment. We all agree that this will be a cost effective and efficient way to reach new library employees.

The Performer's Showcase was held at the Smyrna Opera House on 10/19. Youth service librarians watched 14 performers and had the opportunity to meet 12 more performers in the exhibition hall. Those performers chosen by the librarians and paid for by DDL will be announced sometime in December or January.
