







Q4 At what grade level is it appropriate for students to have access to the following...















Q13 Do you believe there should be additional operational funding for public libraries in Delaware?





Q14 I support increasing Library Standards funding by \$2.25M for the operation of the newly constructed public libraries and expanded range of services available to Delawareans.




