- Legislative Action
 - HB119 made its way out of the Senate, waiting for it to be signed
 - Governor's budget address recreational marijuana money could be used towards libraries. The committee will discuss this at their next meeting in August
 - Everylibrary white paper on Cannabis tax policy

 - School librarians in DE in crisis committee is committed to getting a ratio bill out to the state
